The Neutronial Council Meeting in her November session of 2023 and after floatisting and prayers led by the Holy Spirit took the following decisions:

Appointments: The following appointments have been made:

- a. New National Council Members: The following pastors have been appointed as National Council members as fritam 1st January 2024. They are Prophet Ngah Edward Daboseh and Rev. Mokube John.

- 2. Confirmation and setting apart: The under-mentioned offices have been confirmed and thus set apart:
  - a. Office of the Prophet: The following Pastors after close observation by the NC have been confirmed and will be set apart into the office of the <u>Prophet</u> in the International Convention of December 2023. They are: Prophet Ngah Edward Daboseh, Prophet Inyang Jacob and Prophet Mbi Matthew.
  - b. Office of the Evangelist: The following Pastors whose ministries have been closely observed by the NC have been confirmed as Evangelists. They will be set apart during the International Convention in December 2023. They are: Evangelist Fon Eric, Evangelist Nkweti Sama Raoul, Evangelist Jean Baptist Nyebe, Evangelist Matthew Laodane, Evangelist Simo Gabriel and Evangelist Seta Augustine.
- 3. Church Barrister for Field 5 and 12: Barrister Bella Rolly Claver has been approved as the church lawyer for Fields 5 and 12.
- 4. Internship Contract: Henceforth all administrators are prohibited from employing pastors who have not been duly absorbed by the National Council as the sole employer. Graduates from the seminary will have to sign an internship contract with the administrators within the ecclesiastical jurisdiction of TACC. This contract will cover a period of two years after which the candidate will be examined by the National Council before receiving his application before full employment.
- 5. NEW CENTERS: The following new centres have been created which goes operational as from 1st January 2024, they are:
  - a. Group 31: Mban center made up of Mban and Mengama.
  - b. Group 40: Ngoulmekong center made up of Ngoulmekong and Tsinga village.
